Enhanced Partnership

Discussions have begun with one of our partner schools about developing a new cluster model for training PGCE students. Similar to School Direct [but with the college taking responsibility as the course 'provider'], a small group of schools [possibly a MAT or a group of schools who are used to working together] would join us in recruiting their own set of trainees. They would be able to share in the delivery of aspects of their training and could determine the structure of the school placements. Other schools using this model have found this an excellent way to recruit and train trainees with the expectation that they will apply for posts in their schools as NQTs.
